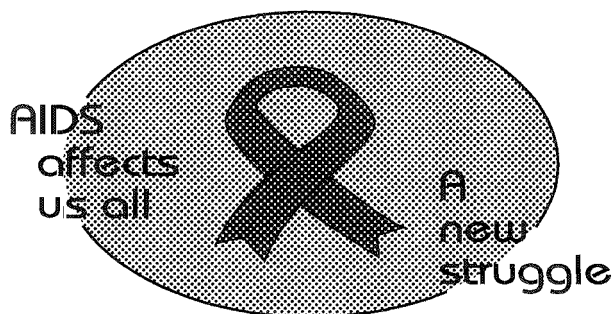

#### CALLING AND SETTING A DATE FOR AN ELECTION OF THE PROVINCIAL LEGISLATURE OF KWAZULU-NATAL IN TERMS OF SECTION 108(2) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996

In terms of section 108(2) of the Constitution of the Republic of South Africa, 1996, read with section 18 of the Electoral Act, 1998 (Act No. 73 of 1998), I hereby, after consultation with the Electoral Commission, call an election for the Provincial Legislature of KwaZulu-Natal and set 22 April 2009 as the voting day.
